Corrado Mora is an **international mediator, trainer and ADR consultant** with over **20 years of full-time practice** in mediation, negotiation and conflict management. He is an IMI Certified Mediator and a CI Arb and CEDR Accredited Mediator.

He is regularly appointed in **cross-border, complex and multi-party disputes**, particularly in **commercial, business, intellectual property, workplace, sports, climate and energy transition matters**.

Corrado conducts **approximately 180 mediations per year**, both ad hoc and under institutional rules. He is known for his ability to manage **high-stakes disputes** involving multiple stakeholders, cultural differences and complex negotiation dynamics.

He serves on the panels of leading international dispute resolution institutions, including ICDR–AAA (New York), WIPO (Geneva), CPR (New York), CEDR (London), CAS (Lausanne), AIAC (Kuala Lumpur), JCAA (Tokyo), PMAC (Ljubljana/Lisbon), AALCO–HKRAC (Hong Kong), DIFC Courts (Dubai) and CAM (Milan). He is appointed as mediator by the ICC International Centre for ADR (Paris), is listed in VIAC’s Mediator Search (Vienna), and is a member of the OECD Roster of Mediators for National Contact Points for Responsible Business Conduct (Paris).

In addition to his mediation practice, Corrado is an **international trainer and academic** in dispute resolution.

He is a Senior Faculty member and Course Director for mediation training programmes of the Chartered Institute of Arbitrators (CI Arb) and regularly delivers training on mediation, negotiation and conflict management for professionals, institutions and public organisations worldwide.

He has conducted more than 1,100 training courses and sessions in mediation and negotiation skills in 25 countries across Europe, Africa, Asia, the Middle East and the Americas, and has served as **contract trainer and consultant for international organisations**, including the United Nations, UNDP, USAID and the European Patent Office (EPO).

Corrado is **Adjunct Professor of Mediation and Negotiation** at the University of Trento – School of Law and frequently serves as visiting professor and lecturer at universities and professional institutions internationally.

A qualified **lawyer** admitted to the Verona Bar, he holds an **LL.M. in Alternative Dispute Resolution**. He conducts mediations in Italian, English and Spanish, both in person and online.



AREAS OF MEDIATION PRACTICE AND APPROACH

Cross-border commercial disputes, including international supply, distribution and agency agreements, termination of long-term commercial relationships, and multi-party business conflicts involving companies operating in different jurisdictions.

Business and corporate disputes, including shareholder and partnership conflicts, governance deadlocks, disputes between founders and investors, and complex business separations.

Intellectual property disputes, including trademark coexistence and brand conflicts, patent and design disputes, copyright matters, licensing agreements, and disputes relating to the commercial exploitation of intellectual property rights, including art-related disputes.

Sports disputes, including contractual disputes between athletes, clubs and agents, sponsorship and image rights disputes, and conflicts involving sports governance or commercial partnerships.

Workplace and organisational disputes, including conflicts between senior executives or teams, disputes relating to organisational restructuring, and workplace conflicts within companies and international organisations.

Climate and energy transition disputes, including conflicts involving renewable energy projects, infrastructure development and sustainability-related commercial relationships, as well as responsible business conduct matters (OECD National Contact Points).

Consumer and regulatory ADR, including ombuds procedures in the energy, utilities and transport sectors under the Italian regulatory authorities (ARERA, ART).

Corrado adopts a pragmatic, results-oriented approach to mediation, facilitative by default and more directive when that helps the parties move forward. It is grounded in independence, impartiality and strict confidentiality, and in a strong sense of responsibility towards the parties and counsel who entrust him with their dispute. He designs and manages a structured process in which parties can engage in candid, well-informed negotiation, rather than merely tactical exchanges, with a view to commercially sound and mutually acceptable outcomes.

His practice frequently involves cross-border disputes, complex commercial relationships and multi-party negotiations. Through careful guidance and process management, he assists parties in moving beyond positional bargaining, exploring the underlying dynamics of the dispute and identifying sustainable solutions. He abides by the IMI Code of Professional Conduct and, in ombuds work, by the IOA Code of Ethics and Standards of Practice.

Attentive to the commercial, legal, technical and relational dimensions of each dispute, he works closely with parties and counsel to understand what is at stake beneath the stated positions, including business priorities, risk and the value of ongoing relationships. He does not impose outcomes, yet he does not hesitate to take a more directive stance when it serves the parties: testing positions robustly, challenging assumptions and coaching the parties to unlock settlement. The focus is on results, while the solutions remain the parties' own. Knowing when to allow room for discussion and when to move the process forward, he draws on a wide range of approaches and techniques, adapting them to the matter and to the people involved. This combination of skill, flexibility and persistence frequently turns a stalled negotiation into a workable way forward, and produces agreements that are durable and genuinely owned by the parties.



REPRESENTATIVE CASE EXPERIENCE

Examples from his practice, described by subject matter only to preserve confidentiality, include disputes involving:

Intellectual property: pharmaceutical and hi-tech patents; app and gaming innovations; brand coexistence and licensing negotiations; trade secrets and proprietary data; copyright in publishing, music and film; cross-border technology transfer, joint-venture R&D ownership and software source code; database rights; industrial design, luxury fashion trade dress and franchise distribution.

Business and commercial: supply-chain disruption and distribution network failures; fractured partnerships, shareholder deadlocks and minority investor protection; joint-venture dissolutions, post-merger integration and asset valuation; corporate governance breakdowns, alleged financial mismanagement and high-value insolvency restructuring; energy and infrastructure projects and delays; warranty and liability claims in heavy manufacturing, technology transfer and industrial construction.

Sports: player contracts and transfer fees; representation rights and athlete-agent commission disputes; trademark licensing, merchandising and counterfeiting; image rights, digital content and personal brand monetisation; sponsorship and endorsement breaches; club-to-club transfer coordination.

Workplace and organisational: team-management and leadership conflicts; intra-organisational and peer-to-peer disputes; discrimination, harassment and whistleblowing matters; performance and role-boundary disagreements; boardroom deadlocks, founder-CEO dynamics and succession standoffs; cultural friction following restructurings, mergers and downsizing.

Cross-border and multi-party: multi-jurisdictional construction disputes involving owners, insurers, engineers and suppliers; international partnerships, consortia and multi-party joint ventures; cross-border estates, inheritance and trust structures; international trade alliance breakdowns; supply-chain networks spanning several continents under conflicting commercial codes.

Delicate and emotionally complex disputes: inheritance divisions among estranged siblings; commercial disputes under severe financial pressure or insolvency risk; family business successions and generational leadership transfers; partnerships broken by perceived betrayal; medical, institutional and professional malpractice claims; closely held company separations blocked by personal animosity.
